MINUTES OF THE DOWNTOWN IMPROVEMENT BOARD

Regular Monthly Meeting Friday, February 28, 2020, 7:30 a.m.

Attendance

Call to Order

- a. Mr. Carro called the meeting to order at 7:30 a.m.
- b. The PensaLocal Award was presented to Lawrence Powell, City Neighborhoods Administrator.

Recurring Agenda

- a. Mrs. Dees confirmed that the meeting was properly noticed.
- b. The board unanimously approved the proposed meeting agenda.
- c. The board unanimously approved the minutes of the regular meeting of DIB held on January 28, 2020.

<u>Parking</u>

- a. The February DPMD consent agenda was unanimously approved.
- b. Mr. Darden and Mrs. Dees provided the parking strategy presentation, received input from Mayor Robinson, and answered questions posed by the board and the audience.

Ongoing Business

- a. Romana Street puppy pit-stop
 - 1. Mrs. Dees reported that Cox Communication has filed for the city permit to remove the pole; engineering reports for the city have been finalized; and progress should begin on the puppy pit-stop next week. Mrs. Dees thanked Councilwoman Hill for the donation of two trees from the city's tree fund.

- b. StreetPlus January report and recommended local contacts
 - Mrs. Dees advised that a third person has been hired and good results are anticipated. Should improvement not be made, three local companies have offered to take over.
- c. Additional street cameras
 - Progress should be made within the next week on installation of the street cameras.
 Mrs. Dees noted that PPD requested one additional camera to be placed on the side of Seville Tower. ED is working with Seville Tower on a cost-share arrangement.
- d. JSG Alley Art
 - 1. Mrs. Dees will seek more intel and will report back to the board on ways in which to invest the \$20,000 previously approved for alley art.
- e. Anti-litter and recycle campaign
 - 1. Mr. Haydn-Slater reported that slogans are being discussed for the anti-litter campaign, including Pick Up Pensacola, or PUP.
