# V. Report from the Executive Director

- a. Holiday Lighting needed repair after the wind storm on October 26th
- b. Pelican Drop Danny Zimmern gave a detailed report on the activities and entertainment being planned for the event.
- c. Palafox Market Mr. Butlin gave a brief update on the market. It is performing very well and has between 100 and 115 vendors each week
- d. Trick or Treat recap Lissa Dees discussed the recent event. All the feedback so far was very positive. Staff discussed keeping the event open until 7:00pm and said that was too late. In the future it would be better to end around 6:30.
- e. Dance Steps Mr. Butlin explained that we were waiting on approval of the installation process from the City.
- f. Audit Mr. let the Board know that the annual Audit field work would begin on November 9<sup>th</sup> and run for roughly the week. This involves pulling a significant amount of sample files, asking Holmes & Co. top run numerous reports generally answering questions on our processes.
